Whether a willful disobedience to or non-implementation of its order may amount to causing any interruption or disturbance in the proceedings of this Tribunal thereby attracting action for contempt, under Section 19 of the Act read with Rule 25?

To include any other question, as may be considered relevant by the Larger Bench to the issue in question, inclusive of the scope and ambit of Section 29 of the AFT Act, 2007 for effecting compliance/execution of the orders of this Tribunal.

In accordance with the order dated 02.04.2024, the Hon'ble Tribunal is pleased to grant permission to all learned counsel who wish to assist through intervention to submit compilations of judgments, rules, regulations, and enactments they seek to rely upon, both in physical and electronic form, on or before 19.04.2024. Learned counsel intending to assist the Larger Bench shall submit an application to that effect along with their names and enrollment numbers.
